MINUTES OF MEETING September 13, 2007

The Sparta Groundwater Conservation District met on September 13, 2007 at 3:10 P.M in the Jackson Parish Community Center 182 Industrial Drive Jenesboro, LA 71251.

The meeting was officially called to order by Chairman Gene Coleman.

The invocation was given by Olevia McDonald. Billy Perritt led the group in the Fledge of Allegiance to the flag.

Agenda Approval

It was moved by Dennis Woodward and seconded by Alice Stewart to approve the agenda after adding two items:

Committee Reports

The following committees made reports:

Public Relation/ Education

Jackle Petritt reported that Hen McGee with USGS made a presentation on the Sparta to Union Parish. She said that the committee met three (3) times in August and September

Long-term Planning

Dr. Alice Stewart said that the committee met and that we are on schedule to meet the approved goals of the Commission. Members of both the public relations and long-term planning have met with Trail Blazer on the 'Save our Sparta' initiative.

Legislative

John Van Bennett was unable to attend today's meeting

It was moved by Herb Byars and seconded by Todd Culpepper to accept and approve the committees' reports. The motion was approved unanimously.

Presentation

Dennis Woodward reported on the efforts of "2007 Save our Sparts Initiative" Dennis reminded the group that Trailblazer had received money from Entergy (\$7500) and Natural Resource Conservation Service (NRCS) - (\$18,000) to be used for Sparta.

A project committee met several times in August and September to review the task list and set-up priorities for the Initiative. The task list from the NRCS was the focus of the committee's function Rick Hohlt, with the Ruston Daily Leader is on the committee of the Save our Sparta Initiative but was unable to attend the Commission meeting today. Dennis brought several compact disc copies of "Be Sperta Smart" ada that Rick had run in the newspaper and was making copies available to Sperta Commission members to take to their local newspaper to be run or utilized in the overall Sparta education of the general public. In addition to the ads, Rick also sent copies of radio spots that could be used throughout the Sparta region. Samples of the Be Sparta Smart ads are attached. (See Attachment

John Stamberg, an engineer with the City of West Mouroe provided an update on the City of West Monroe Sparta Aquifer project with Graphic Packaging. John said the system (1 unit) is in operation treating 0.6 mgd. He had a display showing the system and brought samples of the treated water from the operation. He estimated the cost at 0.45 - 0.65 / 1000 gallons. The Commissioners had an opportunity to ask questions and gather information through discussion of the West Monroe operation.

Other Busines

It was moved by Dennis Woodward and seconded by George Rolfe, Jr. to conduct meeting every two months instead of having monthly meetings. The motion was approved unanimously.

The next meeting will be held on November 8, 2007 in Homer, Louisiana at the Claiborne Parish Police Jury Office Complex at 3PM.

Allen Nipper is LSU-AgCenter discussed the position that they will fill for a Watershed Engineer. He explained that this person would not be a full time Sparta education employee but would be involved with water systems in north Louisiana.

Dennis Woodward moved to adjourn the meeting at 4:30 PM.
