

## SPARTA GROUNDWATER CONSERVATION DISTRICT COMMISSION MEETING Wednesday, December 5, 2018 at 2:00 P.M.

**Call to Order:** The December 5, 2018 meeting of the Sparta Groundwater Conservation District Commission was called to order by Mr. Zack Spivey at 2:00 P.M. at the Lincoln Parish Library Community Room in Ruston LA, in Lincoln Parish. - An update was given on the Louisiana Water Resources Commission's meeting in November and the passage of a LWR Commission Work-Study on 'Sale of Louisiana surface water out-of-state'.
- The USGS is conducting a monitoring and modeling study for the Mississippi Alluvial Aquifer. The MAP Regional Water Availability Study will run until FY21 and will study the Mississippi Alluvial Aquifer from Missouri down to Louisiana.
- The Louisiana Watershed Initiative was discussed, detailing the focus of approx. \$1.2 Billion over 6 years from HUD. The mission is to 'reduce flood risk and improve floodplain management across the state, including through maximizing the natural and beneficial functions of the floodplain.' Technical Workshops and Listening Sessions were conducted across the state. RFP's for funding will tentatively be published in mid-January.
